

# **Beyond 2024 Exhibitor Contract**

#### 1. CHARACTER OF EXHIBIT

The purpose of exhibits at Beyond 2024, consistent with Edwards Construction Group, Inc.'s objectives, is to promote innovation, collaboration, and sustainable growth in the Architecture, Engineering, Construction, and Ownership (AEC/ O) industries. All exhibits must align with this purpose and enhance the event's program. Each Exhibitor agrees to exhibit only products, services, or solutions relevant to advancing knowledge and practices within the AEC/O sector. Exhibitors must comply with the Booth Rules and Regulations provided by Edwards Construction Group, Inc. Exhibitors are expected to maintain the general appearance of the show and refrain from obstructing or adversely affecting other exhibits.

### 2. ASSIGNMENT AND RELOCATION OF EXHIBITS

Assignment of booths will generally occur in the order of registration, or on a first come, first served basis. However, Exhibitor understands and agrees that Edwards Construction Group, Inc. has sole discretion regarding the assignment of booths. Edwards Construction Group, Inc. is not obligated to assign Exhibitor any specific booth preferences. Edwards Construction Group, Inc. reserves the right to alter Exhibitor's assigned location if deemed necessary in the best interest of the event. Before exercising its discretion, Edwards Construction Group, Inc. will contact Exhibitor.

### 3. PAYMENTS

The cost for rental of exhibit space at Beyond 2024 is outlined in the application. Payment in full must accompany the Exhibitor Registration form to enter the booth selection process, or by the deadline of May 1st to maintain registration status. Refunds will be issued if Edwards Construction Group, Inc. does not accept the exhibitor's application. If payment is not received by the deadline of May 1st the Exhibitor Registration application will be considered cancelled.

### 4. CANCELLATION/REDUCTION OF SPACE

In the event that the Exhibitor cancels participation in the exhibit or wishes to reduce exhibit space, Exhibitor shall promptly notify Edwards Construction Group, Inc. in writing. If the cancellation or reduction is received by Edwards Construction Group, Inc. after May 1st, 2024, 50% of the full exhibit price or full price for the space relinquished, will be retained by Edwards Construction Group, Inc. Upon cancellation, Exhibitor loses all right to space and Edwards Construction Group, Inc. reserves the right to reassign that space to another Exhibitor. In addition, the exhibitor loses the right to use any complimentary exhibitor registration badges.

### 5. FAILURE TO MAKE PAYMENT

Any person, partnership, or corporation contracting for space who shall fail to make the payment as herein provided, whether such person, partnership, or corporation desires to exhibit or not, shall thereby and thereupon forfeit all rights to the use of the selected space, and Edwards Construction Group, Inc. shall have the right to dispose of such space in such a way as it may consider to its interests without any liability on the part of Edwards Construction Group, Inc. Any Exhibitor who fails to pay for and occupy said space shall be and shall remain

liable for the payment agreed on.

### 6. BOOTH SETUP AND DISMANTLING

Setup time, exhibit hall hours, and dismantling time are listed in the Exhibitor Service Kit included with Exhibitor Registration notice of confirmation. Each Exhibitor must deliver to the exhibit hall area all equipment, apparatus, goods, materials, etc., and there erect and completely install the display in the space contracted by such Exhibitor no later than thirty (30) minutes prior to the published opening time of the exhibit hall. Work will be strictly prohibited after that time. Property received after the opening must be arranged in spaces only during the hours when the exhibit hall is not open to attendees. In fairness to all exhibitors, Edwards Construction Group Inc.'s exhibit construction guidelines as provided must be observed. All booths must be constructed in compliance with the Americans With Disabilities Act. Exhibits will not be permitted to be packed or removed from the building at any time after installation until the final closing of the exhibit hall unless special permission in writing is obtained from Edwards Construction Group, Inc. Failure to comply will result in a \$300 fine. Booth must be fully staffed during the entire conference. Edwards Construction Group, Inc. reserves the right to make such modifications in the exhibit hours as may be necessary to meet program needs, with full and sufficient notice given to all contracted Exhibitors.

### 7. SOUND RESTRICTIONS

Sound-producing or amplifying devices that project sound must be tuned so as not to exceed 85 dbs. Edwards Construction Group, Inc. reserves the right to determine at what point sound constitutes interference with other Exhibitors. Public address announcements are prohibited.

### 8. USE OF COPYRIGHTED MUSIC

Exhibitor agrees to pay all royalties, license fees or other charges for any music, either live or recorded, or other entertainment of any kind or natures, played, staged, or produced by the Exhibitor, their agents or employees, within the premises by this License Agreement, including but not limited to royalties or licensing fees due to BMI, ASCAP, or SESAC. The Exhibitor agrees to indemnify and hold Edwards Construction Group, Inc. harmless against any and all such claims or charges.

### 9. USE OF SPACE

All promotional material must be distributed from within the confines of the Exhibitor's own contracted space. Materials bearing any name or form of advertisement may not be displayed anywhere other than the space contracted. No Exhibitor shall sublet space allotted. Each Exhibitor is responsible for keeping the aisle or aisles near contracted space free of congestion resulting from demonstrations or promotions.

## 10. MARKETING PARAMETERS

Exhibitors are prohibited from scheduling hospitalities or programs outside of their exhibit contracted space(s) during times of the Edwards Construction Group, Inc. official program.



#### 11. FORCE MAJEURE

Because of the nature of the enterprise undertaken by Edwards Construction Group, Inc., the same being dependent on its securing a sufficient and satisfactory number of Exhibitors at the Conference, it is specifically understood and agreed that if, in the sole opinion of Edwards Construction Group, Inc., it is not practical to carry out the terms of this agreement for any reason, without limiting it to any embargo or regulation of any department or agency of the United States government against the holding or carrying out of said exhibit program as a whole, Edwards Construction Group, Inc. shall have the right to cancel the same and this agreement, in which event any payment made by the Exhibitor to Edwards Construction Group, Inc. shall be returned to Exhibitor, and Edwards Construction Group, Inc. hereby expressly waives any and all claims of any kind and nature except for such amount as Exhibitor has previously paid for space, excepting if said event causes the exhibit program to be canceled ten days or less prior to the opening date of such exhibit program, fifteen percent (15%) of the full exhibit contract fee will be retained by Edwards Construction Group, Inc.

### 12. LIABILITY

Exhibitor must operate and maintain exhibits so that no injury will result to any persons or property. Exhibitor undertakes and agrees to indemnify and hold harmless Edwards Construction Group, Inc. and its officers, board, agents, and representatives from any and all claims for damages, suits, etc., by any person by reason of negligence of the Exhibitor, its agents, representatives, or employees. Exhibitor agrees to release and to indemnify and hold harmless Edwards Construction Group, Inc. from any and all claims for damages, suits, etc., for injuries to themselves or their employees and for damages to property in their custody, owned or controlled by them, which claims for damages may be incidental to, grow out of, or be connected with their use or occupation of space contracted; however, nothing herein shall release Edwards Construction Group, Inc. from any liability for claims, damages, suits, etc., that are the result of the negligence of Edwards Construction Group, Inc.

### 13. INSURANCE

Exhibitor agrees to procure and maintain adequate insurance coverage during the dates of Beyond 2024, including move-in and move-out days, and be prepared to furnish a certificate(s) of insurance to Edwards Construction Group, Inc. if requested. Exhibitor bears the risk of loss due to the inadequacy or failure of any insurance or any insurer, including any insurance that may be provided by Exhibitor, Edwards Construction Group, Inc., or the Madonna Expo Center. Edwards Construction Group, Inc. shall not be liable to Exhibitor for any damages.

#### 14. SECURITY

Edwards Construction Group, Inc. will provide general perimeter security. Exhibiting companies are responsible for the security of their booth and all materials related to their booth. Any company wishing to employ additional security may do so through the official convention security company.

### 15. TAX AND LICENSING

Exhibitors who choose to sell products or services assume full responsibility for securing licenses and collecting all applicable fees and taxes. Exhibitor will comply with all federal, state, and local laws as well as the rules and regulations of the host venue. Exhibitors will be liable for all obligations resulting from noncompliance and will indemnify and hold harmless Edwards Construction Group, Inc. from any and all costs and/or expenses (including counsel fees) involved in addressing or defending any matters arising in whole or in part from Exhibitor's sale of products or services.

### 16. SERVICE INFORMATION

Complete shipping instructions and information regarding furniture, carpet rental, electrical work, labor and dismantling, drayage, etc. will be available to exhibitors in advance. A service desk will be maintained in the exhibit area. All participating exhibitors and contractors must abide by any union jurisdictions in force at the time of Beyond 2024.

### 17. VIOLATIONS

Any violation of these terms and conditions and/or the rules and regulations contained in the prospectus on the part of any Exhibitor will nullify Exhibitor's right to occupy space. Such Exhibitor will not be released from liability and will forfeit to Edwards Construction Group, Inc. all monies that have been paid. In case of any violation of the terms and conditions and/ or the rules and regulations on the part of the Exhibitor, Edwards Construction Group, Inc. reserves the right to terminate the agreement to occupy space, and Edwards Construction Group, Inc. may enter and take possession of the space occupied by the Exhibitor and remove all persons and goods at the Exhibitor's own risk.

### 18. AMENDMENT TO TERMS AND CONDITIONS

Any and all matters or questions not specifically covered by the terms and conditions contained herein shall be subject to the sole discretion of Edwards Construction Group, Inc. Edwards Construction Group, Inc. may, in its sole discretion, make reasonable changes, amendments, or additions to these terms and conditions. Any such changes, amendments, or additions shall be binding on Exhibitor equally with the other terms and conditions contained herein.
